The Government of The People's Republic of Bangladesh has received a USD 150 million Credit from the International Development Association (IDA) – a member of the World Bank Group – for financing the cost of the *Bangladesh Regional Connectivity Project 1 (BRCP-1)*, being jointly implemented by the Bangladesh Land Port Authority (BLPA), National Board of Revenue (NBR) and Ministry of Commerce. Now the BLPA intends to apply part of the IDA Credit for procuring the services of an International Technical Expert (ITE) for its Project Implementation Unit (PIU).

2. The Scope of Services:

The ITE will be responsible for assisting BLPA in evaluating bids and other procurement related and technical matters of the project. The expert will provide quality procurement related advice from a technical perspective and maintaining highest degree of integrity and ethical standard. The ITE will have a significant role in assuring the integrity, fairness, and overall quality of procurement in conformance with the requirements of the regulations of the World Bank and the procurement laws of Bangladesh. He should not have any conflict of interest while working and should keep all the project information confidential. Detail scope of works (Terms of Services) and other information will be available upon request from the address provided below, either through email or in person. 3. General Qualification and Experience:

- Masters in Civil, relevant engineering degree; additional university degree or accredited training on public procurement desirable);
- At least 10 years of experience in in drafting technical content of works and service bidding and proposal document, contract management, and at least 5 years' experience outside home country as technical expert in relevant field

4. Specific skills and Experience:

- Experience in procurement of works, goods and services for World Bank or other donor-funded projects preferred;
- Good knowledge of BOQ interpretation, Detailing, Specifications, Public Procurement, Project/Contract management, Quality Control and dispute resolution;

5. The Bangladesh Land Port Authority (BLPA) now invites eligible applicants to indicate their interest in providing the services. The applicants are requested to submit their: (a) CV (*Curriculum Vitae*) with recent photograph; (b) expected remuneration with a cover letter.

6. The International Technical Expert will be selected in accordance with World Bank's "World Bank Procurement Regulations for IPF Borrowers (July 2016)". It is expected that the Consultant's service will commence by the end of May 2018 at BLPA Head Office, Dhaka. Duration of the consultancy services would be 60 (sixty) days (on intermittent basis).

Expression of Interest (EOI) shall be submitted by **January 22, 2019 up to 5:00 pm (BST)** either in sealed envelope clearly marked "Expression of Interest (EOI) for International Technical Expert" in the email's subject line or on top of the envelope or through email sent to the undersigned address. EOIs received after the last date of submission will not be considered for short listing.
