Bids shall be opened in presence of Bidders' representatives who choose to attend on **13:00 Hours on November 21, 2018** at the office of Department of Health Services, Management Division, Teku, Kathmandu, Nepal. Bids must be valid for a period of 90 days after the day of bid opening and must be accompanied by bid security as mentioned above or any equivalent freely convertible foreign currency. Bid Security shall be in the name of the Bidder and in the case of a Bid Security issued by a foreign bank, the same shall be counter-guaranteed by a Class "A" Commercial Bank in Nepal. Bid Security must be valid for thirty (30) days beyond the bid validity period
6. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
