Government of Nepal, Ministry of Federal Affairs and General Administration, Department of Local Infrastructure (DoLI) is implementing the Trail Bridge Program under Sector-wide and intends to apply part of the funds to cover eligible payments under the Contract for Supply of Wire Ropes through International Competitive Bidding (ICB).

2. The DoLI invites electronic bids from national and international manufacturers of Wire Ropes for the supply of Wire Ropes.

For the purpose of Bidders submitting their bids electronically through Nepal Government's Centralized eprocurement portal <http://www.bolpatra.gov.np>, the Bidders may either purchase the hard copy of Bidding Documents or may choose to download the necessary part of Bidding Documents, prepare their bids and submit their electronic bids as specified in the Instruction to Bidders. In case, the Bidder chooses to download and submit electronically, the Bidder shall be required to deposit the cost of Bidding Document as specified below in the DoLI's Rajaswa (Revenue) account either by direct deposit or by Tele-transfer of deposit in the DoLI's account for the purchase of the bids as specified below and electronic scanned copy (PDF format) of the bank deposit voucher or Tele-transfer certificate shall also be submitted along with the electronic bid files.

The documents submitted after the specified time will not be accepted.

Bids shall be opened electronically after the bid submission in the presence of Bidder's representatives who choose to attend on 16th, November, 2018 at 1:00 pm. at the office of Department of Local Infrastructure (DoLI), Local Bridge Section, Shreemahal, Pulchowk, Lalitpur. Bid and Bid security must be valid for period as mentioned in the table below.
