- 2. After the close of last date ie. 19th August 2019 as per the extended election schedule for receiving nominations, I have scrutinized the nominations received, the details of which are given in the tables in Para 1. above. Overall, the following is observed:
- (i) In 5 out of 9 sectors, valid nominations have been received. The same are listed above.
- (ii) No Nominations have been received in the following sectors:\
 - (a) Architectural Services and Related Services
 - (b) Marketing Research and Public Opinion Polling services/Management Services
- (iii) Thus, in 5 sectors (i.e. Advertising Services, Distribution Services, Educational Services, Entertainment Services including Audio-visual Services, Maritime Transport Services, and Others), there is only one unopposed nomination in each category.
- (iv) In one sector (i.e. Healthcare services including services by nurses, physiotherapist and paramedical personnel) there are two valid nominations.
- (v) In one sector (Distribution Services) there is one nomination which is invalid, since it is made for a sector (Pharmaceuticals) which is not available with SEPC.
- It may kindly be noted that as per Election schedule, eligible candidates have the options to withdraw their nominations on or before 23rd August 2019 (1700 hrs). The template of the same has already been provided with the Announcement letter in Annexure III.

Members are requested to carefully go through the schedule of the elections posted on SEPC website.
