SEPC email dated 11th July, 2024 regarding to inform you about revision in SPEC membership registration fee w.e.f. 15th August, 2024. **Till date the registration fee was based on nature of entity like Private Limited/Limited/Proprietorship/LLP/Trust etc but w.e.f. 15th August, 2024 the registration fee will be based on Services Export turnover/ foreign exchange earnings of the firm for the preceding financial year.** The revised registration fee for new membership registration and membership renewal is as mentioned below:
