Hon'ble Prime Minister's visit of June 2025 marked a milestone in India–Cyprus economic relations. During the visit several high-level MoUs and Expressions of Interest were announced in the fields of Banking, Finance, Technology, Shipping, etc.

- Supply Chains and Raw Materials

The Summit will be attended by a distinguished audience from Cyprus, including Ministers and senior officials, as well as the leadership of apex business organizations such as Invest Cyprus, the Cyprus Chamber of Commerce and Industry (KEBE), the Cyprus–India Business Association (CIBA), OEB, CIFA, CITEA, and Techisland, in addition to CEOs and senior executives from leading Cypriot companies.

In view of the above, Services Export Promotion Council with the support of High Commission of India, CYPRUS is mounting a Business Delegation to participate in the India–Cyprus Business & Investment Summit 2026, which would significantly enhance the substance and effectiveness of the Summit.
