During the recent announcement of New Foreign Trade Policy, Hon'ble Commerce and Industry Minister Shri Piyush Goyal, mentioned that overall exports has already crossed US\$ 750 Billion and is expected to cross US\$ 760 Billion in the current fiscal (as the final data is expected soon). **The services sector exports has shown a phenomenon growth by clocking US\$ 296 Billion by Feb 2023 and further anticipated to cross US\$ 320 Billion when the final figures for the month of March 2023 are released by RBI.** The services sector has shown immense resilience in overcoming the immense impact of COVID and has bounced back to set new benchmark for growth trajectory.

The share of India's services exports in overall global services exports has increased from 4% to 4.4% (as per WTO report 6<sup>th</sup> April 2023)
