Participation Guidelines:

- The above cost is subsidized as per the MAI guidelines, in anticipation of approval from approval from the Ministry of Commerce, GOI.
- Eligible exhibitors can also claim air fare reimbursement (economy excursion class) up to the maximum ceiling limit of Rs.75,000/- as per MAI guidelines upon submission of their claims in prescribed format, with subject to the approval from Ministry of Commerce, GOI.
- Interested companies must have an Import Export Certificate (IEC).
- SEPC Members must have a valid RCMC number.
- Non-members companies with IEC number can become a member. This membership will be applicable for all events in a FY, or till the yearly membership is valid.
- Booth allocation will be done on first-come-first-serve basis.
- Corner booth will be charged extra 10% extra.
- A built-up booth will be equipped with standard package with limited display aides as:
 - 6 sqm 1 Table, 2 chairs, 2 spotlight, 1 fascia name board, carpet, 1 power socket for laptop and mobile charging, 1 wastebin.
 - 9 sqm 1 table, 3 chairs, 3 spotlight, fascia name board, carpet, 1 power socket for laptop and mobile charging, 1 wastebin.

Given the significance, SEPC cordially invites interested members/organisations to proactively participates and submit their duly filled application form in the prescribed format (enclosed herewith) along with an amount of Rs. 1,00,000/by way of NEFT in favour of the Services Export Promotion Council payable at New Delhi latest by <u>15th November 2022</u>. 
